

## NOTICE OF FILING

### DOCKET NO. 2022-96-T

Pursuant to Title 58, Chapter 23 of the South Carolina Code, specifically S.C. Code Ann. §§ 58-23-1010, 58-23-20, 58-23-590, S.C. Code Ann. Regs. §103-190, et. seq., and the Rules and Regulations of the Commission, Gamecock Moving, LLC of 1506 King Street, Columbia, S.C. 29205 has filed an Application with the Public Service Commission of South Carolina (the Commission) to amend its tariff currently on file with the Commission.

Under the application, Gamecock’s existing tariff would become a Midlands and Upstate tariff. This tariff would apply to moves originating in Abbeville, Aiken, Allendale, Anderson, Bamberg, Barnwell, Calhoun, Cherokee, Chester, Chesterfield, Clarendon, Darlington, Edgefield, Fairfield, Greenville, Greenwood, Kershaw, Lancaster, Laurens, Lee, Lexington, McCormick, Newberry, Oconee, Orangeburg, Pickens, Richland, Saluda, Spartanburg, Sumter, Union, and York counties. Most moves under this tariff will originate in Richland and Lexington counties and will be handled by Gamecock Moving’s Columbia office.

The Low Country and PeeDee Tariff would apply to moves originating in Beaufort, Jasper, Hampton, Colleton, Dorchester, Charleston, Berkeley, Georgetown, Williamsburg, Horry, Florence, Marion, Dillon, and Marlboro counties. Most moves under this tariff will originate in the Charleston, Berkley, and Dorchester tri-county area, and will be handled by Gamecock Moving’s Charleston office.
