



Commissioner Appointments

Commissioner Elizabeth B. "Lib" Fleming has been appointed as President of the New Mexico State University Center for Public Utilities Advisory Council. The Council's main objective is to design the Current Issues Program, which is a series of panel discussions on timely topics relevant to the utility world. As President, Commissioner Fleming will oversee the design of the Current Issues Program, coordinate sponsor recruitment, and conduct council meetings, among other duties. She has served on the Council since 2008 and will serve a term of 2 years as President.







Since assuming his Commissionership in July of 2013, Commissioner Comer H. "Randy" Randall has been appointed to the National Association of Regulatory Utility Commissioners' (NARUC) Committee on Gas, Subcommittee on Nuclear Issues-Waste Disposal, and most recently the Committee on Water. The Water Committee aims to increase awareness and understanding about the issues surrounding uses and reuses of water and wastewater.

In addition to his active participation on NARUC committees, Commissioner Randall has spoken at the Commissioner Water Policy Forum, Wall Street Dialogue, and the Emerging Issues Policy Forum, where he discussed distributed generation. He will also be participating on a SEARUC panel regarding the challenges facing the regulated water and wastewater industry in the Southeast during the 2015 Annual Meeting in June.

During the Commission's annual ethics training, Commissioner Randall was appointed to lead a breakout discussion group, where he was tasked with keeping the session discussion on track and encouraged every group member to participate. The chosen group leaders attended training in order to be effective group leaders.

In December, Commissioner Elliot F. Elam, Jr. was appointed to the Federal-State Joint Conference on Advanced Telecommunications Services. The Joint Conference was convened in 1999 as part of the Federal Communications Commission's (FCC) ongoing efforts to ensure that advanced services are deployed as rapidly as possible to all Americans, and it serves as a forum for ongoing dialogue among the FCC, state regulators, and local and regional entities regarding the deployment of advanced telecommunications capabilities. The Joint Conference comprises representatives from state public utility commissions and from the FCC.

Staff Attorney, David Butler, has been a member of the South Carolina Bar Association's Administrative and Regulatory Law Committee for 15 years. In July 2014, David was appointed as Chairman of the Committee.

The Committee is tasked with reviewing changes in law that affect administrative law practice and promoting better relations between Bar members, tribunals of government and regulatory agencies. The goals of the committee are to implement plans to sponsor a CLE at the Bar Convention, monitor, study and make recommendations as appropriate to legislation and other public policy initiatives impacting administrative and regulatory law practice, and plan themes, topics, and

speakers for Committee meetings. David's role as Chairman is to guide the Committee's discussion of an issue and help formulate a Committee position.

David has been an attorney at the PSC for 24 years. In addition to his time at the Commission, David also has been practicing pharmacy since 1971.

PSC Live Streams Its First Hearings



In May, the PSC contracted with SCETV to live web stream its first hearing. The hearing was held regarding Duke Energy Carolinas, LLC and Duke Energy Progress, Inc.'s Distributed Energy Resource Program (DERP). On June 2, 2015, the PSC live streamed the South Carolina Electric & Gas Company hearing regarding DERP.

Based on the PSC's DMS activity, it was determined that the DERP dockets have generated much interest, which led to the decision to live stream the two cases regarding the proposed programs.
