PSC Elects New Officers

The Public Service Commission has elected new officers. Swain E. Whitfield (5th District) was named Chairman and Comer H. "Randy" Randall (3rd District) was named Vice Chairman.

Chairman Whitfield has served on the Public Service Commission since 2008. He is an active member of the National Association of Regu-Utility Commissioners latory (NARUC), where he serves as Co Vice-Chairman of the Committee on Critical Infrastructure, and is a member of the Washington Action Committee, Nuclear Issues and Waste Disposal Subcommittee, Gas Infrastructure Modernization Partnership, and Committee on Gas He is also the 1st Vice President of the Southeastern Association of Regulatory Utility Commissioners (SEARUC), and Vice Chairman of the Gas Technology Institute's Advisory Board.

As Vice Chairman, Commissioner Randall will assist the Chairman with the continued advancement of Commission procedures, regulations, and rulings. Commissioner Randall is a member of NAR-UC, serving as a member of the Committee on Water, Subcommittee on Nuclear Issues-Waste Disposal, and Transportation Task Force.

The newly elected officers will serve two years as Chairman and Vice Chairman.

Commissioner Randy Randall and I were sworn in as Vice Chairman and Chairman, respectively, effective July 1 of this year. I would like to thank my colleagues for this honorable and yet awesome responsibility. It has been a very busy time these past six months as we have held nu-



merous hearings, including a major Base Load Review Act case. These cases continue to be critical to all South Carolinians. Our Commissioners continue to hold Committee Chairmanships and other important roles at NARUC and NARUC affiliates. Through the dedication and hard work of our Commissioners and Staff, the Commission has continued our core mission and continues to be a National model of restructuring through South Carolina Act 175, as the Legislature intended.

South Carolina has again endured another tough year with the devastation of Hurricane Matthew. However, with the proactive measures taken by our State Leaders and many others, damages and loss of life in South Carolina were not as bad as was predicted. We suspended a major hearing so that utilities and others could go into hurricane readiness mode. The state's utilities, the Coops, the Office of Regulatory Staff, the Emergency Operations Center, and many others are to be commended on how quickly they restored power to most areas of our State, and for the tireless efforts to continue to work until everyone's power was restored. Once again, South Carolina survived a major event and showed resiliency. As we don't know what the future holds, continue to pray for our great State as we head into this holiday season. I would like to wish you and your family a Merry Christmas and a healthy and prosperous 2017.

PSC Participates in Annual Ethics Training

As mandated by Act 175 of 2004, members of the Public Service Commission must attend a workshop of at least six contact hours concerning ethics and the Administrative Procedures Act. This year, the PSC hosted a joint ethics training with the Office of Regulatory Staff. The diverse panel featured six speakers from many different backgrounds.



Michael Burchstead, General Counsel of the SC State Ethics Commission, discussed the Rules of Conduct and other State Ethics Act issues for public employees.



Desa Ballard, Esquire, presented examples of judicial misconduct, including cases of impartiality and social media blunders.



Judge Thomas W. Cooper, Jr. covered the Code of Judicial Conduct, including a history of the Code, and the five Judicial Canons.



Dr. R. Gregg Dwyer, MD, EdD, DFAPA, FASAP, discussed healthy ethical stress coping mechanisms, substance abuse, and mental health.



Colin Miller, Associate Dean of Faculty Development at the University of South Carolina School of Law, presented on the South Carolina Administrative Procedures

Act and Rules on Evidence.



Chris Johnson, Esquire, presented on ethical issues in the workplace. Examples included office gossip and social media.

Commissioner Swain E. Whitfield Elected as Chairman of GTI PIAC

In October, Commissioner Swain E. Whitfield was elected Chairman of the Gas Technology Institute's (GTI) Public Interest Advisory Committee (PIAC). Julie Brown, Chairman of the Florida Public Service Commission, was elected as Vice Chairman of the PIAC.

GTI is the research and development arm of US natural gas consumers and gas distribution companies. Its research has produced over 700 products, processes, and techniques that have lowered the cost of natural gas supply, increased the safety of gas pipeline and distribution systems, and increased the efficiency of consumer and industry end-use appliances.

The PIAC provides GTI with strategic advice on which research and development is in the public interest. As Chairman of the Committee, Commissioner Whitfield will lead the PIAC in its duties. "I am honored to be elected Chairman of the PIAC. It is

GTI is a cutting edge research and development organization and operates an R&D lab like no other in the world.
