

Commissioner Appointments

In June, Commissioner Swain E. Whitfield was appointed as 2nd Vice President of the Southeastern Association of Regulatory Utility Commissioners (SEARUC). SEARUC focuses on the advancement and education of commission regulation through the study and discussion of subjects concerning the operation and supervision of public utilities to protect the people with respect to regulation of the Southeastern States. As 2nd Vice President, Commissioner Whitfield will support the 1st Vice President and President of SEARUC in the duties and actions of the Association.







In September, Commissioner John E. "Butch" Howard was appointed as the Chairman of the NARUC Subcommittee on Education and Research by NARUC President Lisa Edgar. The Subcommittee is responsible for the oversight of NARUC's educational and research programs. In 2015, the Subcommittee organized the 13th edition of the NARUC New Commissioner Regulatory Orientation, State Electricity Regulators Capacity Assistance Training, NARUC's Summer Internship Program and established several scholarship opportunities.

Additionally, Commissioner Howard serves as Director of NARUC's Utility Rate School, and is a member of the Committee on Water and Subcommittee on Clean Coal and Carbon Sequestration. Commissioner Howard is also a member of the Water Research Foundation's Public Council on Drinking Water Research, New Mexico State Center for Public Utilities' Advisory Council, and the Department of Homeland Security's Water Sector Government Coordinating Council.

In July, Commissioner Elliott F. Elam, Jr. was appointed as a member of the NARUC Telecommunications Act Modernization Task Force (TeAM). The mission of TeAM is to ensure that the State's voice is heard and that NARUC is positioned to respond quickly to any effort to amend the laws governing the nation's telecommunications sector. "The level of legislative, regulatory, and consumer activity in modern telecommunications is unprecedented. TeAM will be a prime vehicle for ensuring that NARUC and its members are actively engaged in these discussions," NARUC President Edgar said of the Task Force.

Additionally, Commissioner Elam is a member of NARUC's Committee on Telecommunications and the Federal Communication Commission's Federal-State Joint Conference on Advanced Telecommunications Services. He assumed his Commissionership in July 2014, and represents the 2nd Congressional District.

South Carolina has endured a difficult year, but has shown immense resiliency and is stronger than ever. I'm proud of our agency for its recent contributions to the community.





Flood Relief Efforts

In response to the recent devastating floods that took place in South Carolina, PSC Commissioners and Staff banded together to provide relief to those displaced. The PSC donated food and paper items to Beacon Church so they could host a worship service and lunch for the Pine Glen Community in Irmo, SC. The PSC's efforts helped feed over 150 people in the community.

Additionally, the PSC donated \$125 to Harvest Hope Food Bank, equating to 625 pounds of food for those in need following the floods.
