PSC Announces Public Hearing Dates in July and August for Dominion Energy Rate Case in North Charleston, Aiken, Florence, and Columbia

Columbia, South Carolina—The Public Service Commission of South Carolina has scheduled four days of public night hearings in [Docket No. 2023-70-G](#), which involves Dominion Energy South Carolina, Inc.’s request for a rate increase. These public hearings will take place on the following dates at the listed locations:

In their application before the Commission, Dominion Energy South Carolina, Inc. has proposed a rate increase for residential (Rate 32S and Rate 32V) and commercial (Rate 31) ratepayers. The average monthly bill impact is projected to be an increase of \$3.95 (6.22%) for the average residential (Rate 32S and Rate 32V) customer and \$7.87 (6.23%) for the average commercial (Rate 31) customer.

All Dominion Energy South Carolina, Inc. ratepayers are invited to speak before the Commission to share their opinion of the company’s request and their experiences with past service from the company. Testimony is limited to three minutes and witnesses will be called up in the order in which they signed up to speak. Witnesses

can only testify at one of these four public night hearings. Dominion Energy South Carolina, Inc. customers who wish to testify in these hearings can do so by preregistering in one of three ways:
