South Carolina Public Service Commission Schedules Public Forum to Gather Feedback from South Carolina Stakeholders

Columbia, South Carolina—Per [Commission Order No. 2025-181](#), the Public Service Commission of South Carolina has scheduled a public forum for Friday, June 13th, 2025 at 9:30 a.m. At this forum, South Carolina utility consumers and other stakeholders are invited to provide feedback and comments related to efficiency, effectiveness, timeliness, fairness, and the user friendliness of the commission's regulatory processes. Suggested topics for discussion include, but are not limited to:

1. Notice of public hearings;
2. Public hearing scheduling, location selection, and time allotted for witness testimony;
3. The value of filing pre-hearing briefs;
4. The value of pre-hearing, post-hearing, and status conferences for planning and scheduling proposed orders;
5. The value of pre-hearing, post-hearing, and status conferences for planning the timeframe to issue commission orders that are not governed by statutory deadlines, including suggestions for any particular dockets that necessitate a commission decision within a specific timeframe;
6. Commission Business Meeting time and schedule;
7. The commission's docket management system;
8. The commission's allowable ex-parte communication briefing process;
9. The commission's process for selecting consultants in applicable dockets; and
10. The commission's website and meeting livestreaming processes.
