## **MEDIA RELEASE: Public Service Commission Schedules Allowable Ex Parte Briefing for October 24<sup>th</sup> related to the Infrastructure Investment and Jobs Act and the Inflation Reduction Act**

The Public Service Commission of South Carolina (PSC) has scheduled an allowable ex parte briefing at the request of Duke Energy Carolinas, LLC and Duke Energy Progress, LLC to discuss the Infrastructure Investment and Jobs Act and the Inflation Reduction Act. The briefing is scheduled for 2 p.m. on October 24<sup>th</sup> at the PSC Hearing Room at 101 Executive Center Drive, Suite 100, Columbia, SC 29210. An allowable ex parte briefing is a form of communication between the PSC and a person or organization involved in a PSC docket or nondocketed item. These briefings are conducted in accordance with [SC Code section 58-3-260\(c\)\(6\)](#). Allowable ex parte briefings allow the PSC to receive information from persons involved in utility matters that come before or are likely to come before the Commission without violating the ethical standards to which the PSC adheres. Registration is required for all in-person attendees so that the record can be certified as required by law and registration will be available upon your arrival at the Commission's office. Preregistration is required for all those who attend virtually or wish to watch the real-time broadcast. The preregistration link [is available here](#).
