### **PSC Sets Public Hearing Date for Piedmont Natural Gas Company, Inc. Case**

On Monday, July 25<sup>th</sup>, from 9 a.m. to 1 p.m. and from 4 p.m. to 8 p.m., the Public Service Commission of South Carolina will host a public hearing for Piedmont Natural Gas Company, Inc. customers to voice their opinion of the company's performance and the request made by the company in [Docket No. 2022-89-G](#). This hearing will continue (if necessary) on Wednesday, July 27<sup>th</sup> during the same hours (9 a.m.-1 p.m. and 4 p.m.-8 p.m.).

In their application before the Commission, Piedmont Natural Gas Company, Inc. has proposed a rate increase for residential, commercial, and industrial ratepayers. The average month bill impact is projected to be an increase of \$3.83 (6.2%) for the average residential customer and \$4.03 (1.7%) for the average commercial customer.

Piedmont Natural Gas Company, Inc. customers who wish to testify in this hearing can do so by preregistering in one of three ways:
